Dear Chair Chartrand:

The Florida Council of 100 has always asserted that the single most important thing Florida can do is develop a world-class workforce infrastructure so our citizens have the career tools they need to compete and prosper in the ever-changing global economy. Florida's academic success over the past 15 years has been profound, moving Florida from a bottom performing to top performing educational system. The centerpiece of that success is a durable commitment to rigorous standards and meaningful assessment. In these, Florida has become a national leader. We especially commend the State Board of Education for the most recent reform, the Florida Standards, which are researched-based, the most rigorous available, and designed by a diverse group of educators, experts, and parents from Florida and beyond.

But standards without assessment accomplish little. We must have the right assessment tools to ensure that our students are learning the standards. Testing is difficult but vital. Being able to learn and absorb information and then reflect that knowledge on a test is crucial preparation for any career. The Florida Standards Assessment will challenge students to think critically (like employees in the workplace), rather than relying on rote memorization.

We are acutely aware of the growing debate around assessments. We are sympathetic to the challenges of introducing new standards and implementing a statewide assessment system. It will be hard work, and our school districts and teachers deserve our full support. We understand there are times when accountability systems must be flexible to remain aligned with educational reforms. For this reason, the Council of 100 fully supports designating the 2014-15 school year as a measurement baseline and holding schools harmless from accountability penalties during that time. However, we strongly oppose the extension of the hold harmless provisions beyond the 2014-15 school year unless district education leaders can conclusively demonstrate that further extension is in the best interests of our students. Further delay risks a loss of momentum, deprives students
